Why am I getting this?

- Your child has just created an Autodesk Kids' Community account through Tinkercad – a free, easy online app anyone can use to create and print 3D models – and provided us with your email to get your approval.
- We take your child's privacy very seriously, and work hard to keep Autodesk Kids' Community safe and friendly. To comply with the U.S. Children's Online Privacy Protection Act (COPPA), we must get parental permission before allowing kids under the age of 13 to join. Here are more details on our privacy practices.

What is the Autodesk Kids' Community?

- Autodesk Kids' Community is a collection of applications that help your child learn about design, 3D printing, electronics, programming, and more through hands-on projects.
- Autodesk Kids' Community includes Tinkercad.

Important notes:

- Once approved, your child can create and share projects, post comments, upload images, collaborate with other Tinkercad users, contact customer service, and save wishlists for projects and kits.
- Children may be able to share personal information while participating in some of these activities, but once you create your moderator account, you can log in to see what they've been up to, moderate their activity, and change their username and password as necessary.
- To help tailor app's experience to your child's needs and interests, or to display ads for age-appropriate Autodesk Kids' Community apps, we may use persistent identifiers to collect basic information about your child's visit.
- **Your child can view projects and explore tutorials while waiting for your approval, but their temporary account will expire and be deleted along with your email address if not approved within 14 business days.**
